Northwest Power and Conservation Council Systems Analysis Advisory Committee January 19, 2021

John Ollis, NWPCC, began the meeting at 1:00pm, noting that minutes from the January 8th SAAC meeting will be posted soon. Chad Madron, NWPCC, explained how to best engage with the Go-to-Webinar platform.

HYDSIM Constraints John Fazio and Dan Hua, NWPCC

The presentation explored the challenges in meeting high-priority river constraints in both classic GENESYS and HYDSIM before looking at the challenges in meeting all high-priority river constraints in the redeveloped GENESYS. Implications for regional deficits and needs assessment for the Plan were also discussed.

High Priority River Constraints Discussion-Redeveloped GENESYS John Ollis, NWPCC

Fred Heutte, NW Energy Coalition, asked what historical data was not available. John Ollis, NWPCC, said some of the historical data for all of the plants is limited. John Fazio, NWPCC, elaborated, saying neither he nor employees at BPA have had time to fine-tine all of the many constraints relative to climate change data. He used the example of flat-spill amounts to illustrate.

Heutte clarified that the data is not missing but a complete set of re-analyzed data that includes a climate effect is not yet available. Dan Hua, NWPCC, answered yes. Ollis agreed that there needs to be some sharpening of the numbers but this is good information for now.

Scott Levy, Blue Fish, confirmed that the Minimum Operative Storage receives a 0 deficit costs and 4500/MWh for the higher constraints. Ollis responded by saying these were the explored deficit costs and the minimum operative storage is actually around \$600,000/KFSD. He said if he made it higher there would be higher than the Dworshak max flow penalty.

Levy understood the strategy but asked if the 4500 bumps the other numbers. Ollis said no. Levy asked if the numbers on [Constraint Violations in Zero Cost Deficits] would change. Ollis said they may tinker with the numbers and report back, but thought these numbers were yielding decent results. Levy thought that was a good approach.

Ollis asked for questions or comments to be sent to him and ended the meeting at 3:00pm.
