Agenda item: Great Northern Landscape Conservation Cooperative Presenter: Tom Miewald, Sonya Hall

Discussion:

Tom Miewald (USFWS) and Sonya Hall provided a briefing on the Great Northern Landscape Conservation Cooperative (GNLCC). They provided general background information on the project and more specific information on Columbia Basin Partners Forum and the Arid Lands Initiative. They described the project priorities and progress to date. It was stated that the freshwater/riveriene component has not been fully brought into the process yet and they are still determining priorities for this component before it is coordinated with the terrestrial component. Committee members asked who was involved in setting the priorities and whether Subbasin Plans were part of the process. Agenda item: Operational and Secondary Losses Definitions Presenter: Peter Paquet

Discussion:

The group continued its discussion on defining operational and secondary losses, with a goal of bringing a recommendation to the Council for its consideration at the April, 2015 meeting. This resulted in the following draft:

WAC Markup - 2/12/15

Operational and secondary impacts are generally expressed over time and will continue for the life of the hydropower system operation. These impacts have not been fully assessed and may not have been mitigated for as part of construction and inundation losses.

Operational Impacts - Direct changes in river hydrology, hydraulics, sediment and nutrient availability and/or transport that cascade throughout the ecosystem to alter physical and ecological processes, vegetation communities, which directly affect fish and wildlife communities. Operational impacts can also occur within reservoirs as a result of fluctuating water levels which cause shoreline erosion.

Secondary Wildlife Impacts Losses - The indirect-changes in ecosystem functions directly attributable to the construction and on-going operation of the hydropower system, such as food web alterations, contaminant concentrations in reservoir sediments, and other systemic changes stemming from the construction, inundation, and/or operation of the hydropower system. Secondary impacts losses also include the changes in human land uses within the historic floodplain enabled by dam operations. All of these changes cause direct effects reductions in wildlife communities and/or their habitats.
