#### **September 13, 2023**

Council Chair Jeffery Allen brought the meeting to order at 9:01 a.m. PST. Council Members Ginny Burdick, KC Golden, Doug Grob, Mike Milburn, Louie Pitt Jr., Thomas L (Les) Purse, and Ed Schriever were in attendance virtually. The next Council meeting is scheduled for October 11-12, in Redmond, OR and via webinar.

#### **Reports from Committees Chairs and Executive Director**

#### **Fish and Wildlife Committee**

Member Milburn, Fish and Wildlife Committee Chair, reported on the fish and wildlife committee meeting held on September 12, 2023.

#### 1. Fish and Wildlife Committee Update and Planning

Patty O'Toole, the Council's Fish and Wildlife Division Director gave a quick update on this month's brief agenda, and shared the October 2023 and November 2023 Council

Meetings will be longer in length due to more agenda items. O'Toole suggested including a future agenda item for a presentation on ocean harvest based on interest; the committee agreed this presentation would be useful for the Council and for educating the members and the public.

#### 2. Update the Intermountain Province Subbasin Data Management Project

Kris Homel, the Council's Biologist for Program Performance, introduced Dan McMeekan, Water Resources Specialist with the Intermountain Province Subbasin Data Management Project, Kalispel Tribe. McMeekan gave a presentation on the resources available to the region through the Intermountain Province Subbasin Data Management Project by the Kalispel Tribe and how this project relates to the Council's Fish and Wildlife Program. This presentation addressed the seven questions on data management projects set by the Council to better understand the specific work that each data management project is doing, how they relate to each other, and how they relate to the Council's Program.

#### **Power Committee**

Member Grob, Power Committee chair, reported on the power committee meeting held on September 12, 2023.

#### 1. Power Committee Update and Planning

Jennifer Light, the Council's Director of Power Planning, gave an update on power staff work, including enhancement of the GENESYS model, and the continued tracking of market and transmission efforts across the west. Light also shared the news of a new power staff hire, Tomás Morrissey, and that the power division is preparing for an offsite retreat to plan for the mid-term assessment and the 9th power plan.

## 2. Avista 2023 Integrated Resource Plan

Tina Jayaweera, Council's Senior Advisor, introduced James Gall, Manager of Integrated Resource Planning, Avista. Gall gave a presentation on key findings from Avista's 2023 Electric Integrated Resource Plan covering their projected demand requirements and how to best meet divergent energy policies between Washington's Clean Energy Transformation Act (CETA) requirements and Idaho's least cost planning requirements.

#### 3. PacifiCorp 2023 Integrated Resource Plan

Annika Roberts, Council's Resource Policy Analyst, introduced Randy Baker, Director of Resource Planning at PacifiCorp. Baker presented the findings from PacifiCorp's 2023 Integrated Resource Plan (IRP), focusing on key trends and areas of interest. This plan continues to build on goals set in previous plans and identifies investments in modernized transmission, renewable energy, demand response, and advanced nuclear resources.

# 4. Recommendation for New Capital Expansion Model

John Ollis, Council's Manager of Planning and Analysis, presented a recommendation for a new modeling tool and change in approach that will enable the improvement of the Council's analytical capabilities. Ollis discussed the power plan process flow and the options available for modeling new capital expansion. The Committee asked for more time and more information before making its recommendation to the full Council. Staff will bring this item back in October.

#### **Public Affairs Committee Report**

Member Pitt Jr. shared discussion points from the Council's public affairs committee meeting held on Monday, September 11th. The topics of the meeting were the

congressional tour, government affairs strategy, and communications. The congressional tour was determined to be successful with 20 Congressional staff in attendance, whose knowledge of the Council expanded while forming relationships. Regarding government affairs strategy, the Council has been working with Chris Huckleberry, and there needs to be further discussion amongst the committee in determining a long-term strategy. Staff shared with the committee that the Council is hiring two communication staff members, one to be focused on power and one to be focused on fish and wildlife. Member Pitt Jr. stated it was determined that communication strategies need to be refreshed to meet the needs of the public to be informed of the Council's work.

#### **Executive Director Report**

The Council's Executive Director, Bill Edmonds highlighted the important work of the Council this year in resource adequacy and fish and wildlife performance measurement, effort that has contributed to laying the foundation for future fish and wildlife programs and the power plan. Excitingly, the Council is engaging in new ways to communicate about our work – and at the same time our work is becoming even more newsworthy. Edmonds shared that the 2024 Council Meeting calendar has been posted. The four cities for 2024 Council Meetings will be Coeur d'Alene, ID in February, Olympia, WA in April, Helena, MT in June, and Astoria, OR in September.

# **Council Meeting Agenda Items**

#### 1. Update on Project #2017-005-00, Pacific Lamprey Conservation Initiative

Council staff Mark Fritsch began the agenda item with a brief overview of umbrella projects generally and why the Council is hearing about Pacific Lamprey Conservation & Restoration in the Columbia River Basin. Fritsch introduced presenters Ben Clemens, Kelly Coates and Max Calloway with the Pacific Lamprey Conservation Initiative. The presentation provided an update and overview of this project's accomplishments and highlighted that it has been a cooperative effort among agencies and tribes. The project is aimed at securing funding for critical pacific lamprey restoration initiatives and aligns with concurrent efforts in the Columbia River Basin. This presentation offered a progress report on the project's achievements and outcomes, as advised in the Council's 2022 Anadromous Fish Habitat and Hatchery Review.

## 2. Northwest Energy Coalition (NWEC) Remarks

The Council's Director of Power Planning, Jennifer Light introduced presenter Lauren McCloy, Policy Director at the Northwest Energy Coalition (NWEC), who spoke about the NWEC and explained the current priorities of the organization. During the presentation, McCloy presented insights on regional initiatives, focusing on BPA's post-2028 contracts. Additionally, McCloy highlighted NWEC's organized market priorities concerning regional market developments. McCloy also discussed energy efficiency, elaborating on the NEEA 2025-2029 strategic business plan.

#### 3. Perspective on Regional Transmission Planning Needs

John Ollis, the Council's Manager of Power Planning and Analysis introduced Spencer Gray, Executive Director, Northwest and Intermountain Power Producers Coalition (NIPCC). Gray initiated the presentation by delving into the operations and objectives of the NIPPC. Gray shared his background and his deep appreciation for the Council's endeavors. Furthermore, Gray provided his perspective on transmission needs, challenges, and opportunities within the Northwest region underlining the necessity for substantial new resource development. Acknowledging the critical requirement for extensive resource expansion within the region, Gray emphasized that NIPPC offers a distinctive viewpoint on the transmission needs and challenges. He delineated their comprehensive workplan, which involves closely monitoring market efforts, including a thorough analysis of day-ahead market offerings and transmission planning.

#### 4. Draft Policy for Provider of Choice

Jennifer Light, the Council's Director of Power Planning introduced Kim Thompson, Vice President of NW Requirements and Sarah Burczak, Policy Lead, at Bonneville Power Administration. Thompson began the presentation by providing a high-level overview of the Provider of Choice Policy elements and timeline. Thompson spoke about BPA's public engagement process, including dozens of meetings and numerous workshops held between April 2022-April 2023. These meetings explored topics including rate construct, acquisition or resources, net requirements, and carbon. Furthermore, Thompson discussed the draft policy overview comprised of a variety of important policy elements and concluded the presentation by sharing the formal public comment period.
