SUBJECT: Update on RM&E/Artificial Production Category Review and BiOp Fast-track

proposals review

RM&E/Artificial Production Categorical Review

At the February meeting, staff presented a schedule that would have the RM&E/Artificial Production categorical review beginning on April 2, 2010. After consideration of several issues, Council and Bonneville staffs agree that an extension of the start date may be warranted to 1) allow the Taurus team time to program all essential components for the proposal form intake; 2) allow for public feedback on the Monitoring and Evaluation Review and Reporting document after the Council releases it for public comment; and 3) allow time for project proponents to test the new proposal system and provide feedback. Council staff will have available at the Committee meeting, a detailed schedule reflecting a start date of between April 2, and June 1, 2010 for the categorical review.

Fast Track BiOp Projects

The ISRP completed its initial review of the 19 proposals on February 24th. See http://www.nwcouncil.org/fw/budget/2010/rme. Attachment 1 is a summary of the ISRP's initial recommendations by project. The recommendations represent a final review for a subset of projects, while others represent a preliminary review with a "response to ISRP requested".

The schedule has been updated to reflect a public comment period (Attachment 2). The major change to the schedule is the date that the Council makes recommendations to BPA, which will occur at the April meeting rather than the March meeting.

Attachment 1. ISRP Initial Review of BiOp Fast Track Proposals (ISRP 2010-7)

The ISRP found that 9 proposals met scientific review criteria; 5 of these had qualifications that the ISRP recommended could be considered by the Council and addressed by the proponent and BPA during contracting. These 9 proposals are ready for immediate Council and BPA decisions. In response to the Council and BPA's stated desire to implement the fast track action in 2010, the ISRP considered the option to specifically identify if a fast track work element is justified independently of other project actions. The ISRP found that 2 proposals justified the fast track component of their project but the complete project needed a response. These 2 proposals received an "in part/response requested" recommendation. The ISRP requested a response on the remaining 8 proposals.
